G. DESCRIPTIVE REPORT

1.0 General Observations/Remarks of the Project on:

1.1 Background

The project is located in Kazirchar union under Muladi upazila of Barisal district. The place is only 30 km away from Barishal Sadar. It is located in the north-east of Sadar upazila. The place is located on both banks of the Koyla river. The village of Bahadurpur suffered greatly due to the erosion of the Koyla river. If the necessary measures were not taken to prevent river erosion, about 5,000 people would have been displaced. Public and private facilities in the area were under threat from river erosion. Bahadurpur village, markets, shops, Grameen Bank office, houses, schools, agricultural lands and other infrastructures suffered from river erosion.

To solve the problem of river erosion, local people have been demanding to take necessary steps. Hon'ble MP of Barisal-3 constituency has requested the Hon'ble Minister of Water Resources to take necessary steps to solve the problem of river erosion in the project area through DO letter.

In this situation, a 6-member technical committee was formed to study the proposed project. The committee submitted its report in August 2017. The technical committee in its report has recommended the implementation of the work. In accordance with the recommendations of the Technical Report, the current DPP has been prepared.

1.2 Justification/Adequacy:

- About 3.20 km bank line and 160 hectares of land will be protected from Koyla river erosion, Thereby improving
 the project area's communications with the main lands of Bangladesh and through farming it has a huge positive
 impact on the economic activities of the local people.
- Kazirchar union, Grameen Bank office, markets, primary/secondary school, homestead, cultivable land, road, and other private & public properties will be saved in the area from the Erosion of Koyla river. The approximate value of the properties to be saved is Tk.4809.00 lakh.
- The Security and national economic situation of the area will be improved.
- There will be poverty alleviation and employment opportunities.
- Will have a positive impact on the environment.

The main objective of the project is:

- To arrest erosion of the project area and will ensure safety of public and private properties.

In this situation, a 6-member technical committee was formed to study the proposed project. The committee submitted its report in August 2017. The technical committee in its report has recommended the implementation of the work. In accordance with the recommendations of the Technical Report, the current DPP has been prepared.

Accordingly, instructions of Water Resources Ministry, Bangladesh Water Development Board taken up the mentioned project in cooperation by field level of Barishal O&M Division, BWDB, Barishal.
